

"<u>You,"</u> or "<u>Your</u>" - the person identified on the Order who is renting a Meter or purchasing services.

2. METER RENTAL

2.1 Fees

- (a) We will invoice you the Meter rental ("rental") fees listed on the Order.
- After the Initial Term, we may increase the rental fees in accordance with the Master Agreement.

- (b) REPAIR OR REPLACEMENT IS YOUR SOLE REMEDY.
